

I am directed to refer to the Cabinet approval circulated vide letter No. P&DD/Admin/7778-7830/209 September 15, 2009 and subsequent Govt. Notification No. P&D/Gen/ 1575-1675/2011 dated 11-3-2011, regarding the enforcement of AJK Composite Schedule of Rates (CSR) applicable to all ten districts of AJ&K for estimation of the development projects.


