#### 11). Observations/Findings:

- i. This project is part of "Acquisition of Land, Construction of Buildings and Provision of Furniture for 6 new High Schools of District Bhimber (revised) costing Rs.238.740 million. It is total discretion of the Executive Engineer to which sub-project he wants to doze more.
- ii. Work schedule was not found available with the executing staff nor has its allocation been conveyed to the executing staff.
- iii. Honey combing has been observed in the beams of rooms and columns of hall due to not use of vibrator during pouring of concrete.







Gap has been observed between the window frame and wall of a room because of non-verticality of wall and its plaster.





Poor workmanship of masonry in the Boundary wall has been observed as neither the bricks are laid horizontally nor vertically in a course. Shop drawings of the items to be manufactured are not available and approved by the Engineer in charge.



Poor workmanship in formwork of columns of hall has been observed.



Ply door surface has been disturbed at its erection phase.



Encroachment in the school land has been observed by a local as a result of a temporary shop (Khoka).



Marble tiles on slab roof of a room has been executed instead insulation. In the BoQ, roof insulation has been proposed.

- i) Skilled labor should be hired to improve the quality of work.
