

### **Background**

The Global MICS Programme was developed by UNICEF in the 1990s as an international multi-purpose household survey programme to support countries in collecting internationally comparable data on a wide range of indicators on the situation of children and women. MICS surveys measure key indicators that allow countries to generate data for use in policies, programmes, and national development plans, and to monitor progress towards the Sustainable Development Goals (SDGs) and other internationally agreed upon commitment.

#### AJ&K MICS 2020-21

The Multiple Indicator Cluster Survey (MICS), AJ&K was carried out in 2020-21 by Bureau of Statistics, AJ&K (P&DD) in collaboration with United Nations Children's Fund (UNICEF), as part of the Global MICS Programme (Round 6). Technical support was provided by the United Nations Children's Fund (UNICEF). AJ&K MICS, 2020-21 is the second MICS in AJ&K since 2007-08.

AJ&K MICS, 2020-21 in a district-based survey covering more than 170 indicators, on topics like maternal and child health and nutrition, child protection, water and sanitation etc. The survey results are critically important for the purposes of SDG monitoring, as the survey produces information on 33 global SDG indicators.

As per MICS global standards, 19 statistical snapshots were also developed on different thematic areas to highlight key findings of survey. - To provide high quality data for assessing the situation of children, adolescents, women and households in AJ&K;
- To furnish data needed for monitoring progress toward national goals, as a basis for future action;
- To collect disaggregated data for the identification of disparities, to inform policies aimed at social inclusion of the most vulnerable;
- To validate data from other sources and the results of focused interventions;
- To generate data on national and global SDG indicators;
- To generate internationally comparable data for the assessment of the progress made in various areas, and to put additional efforts in those areas that require more attention;







## SAFELY MANAGED DRINKING WATER SERVICES (BY DISTRICT)




